Sealed bids for Contract No. TU-241, Waterline Extension for RUPCO Project for the Cherry Hill – Sawkill Road Water District, Town of Ulster, Ulster County, New York, are sought and requested as set forth in drawings and specifications prepared by Brinnier and Larios, P.C., 67 Maiden Lane, Kingston, New York 12401.

The contract will have one (1) proposal: General Construction. Bidders must bid on all items of work in the respective proposal.

The project consists of furnishing and installing approximately 1,195' of 6" and 8" ductile iron water main (Thickness Class 52), including, but not limited to: maintenance and protection of traffic, site preparation, trenching, house service laterals, valves, hydrants, water main thruway crossing, backfill, site restoration, and other related work.

Attention is also directed to the fact that the Contractor will be governed by New York State and Federal Labor Standards Provisions, which are made part of this specifications and contract.

The bidder, by signing his proposal, certifies that he is fully aware of the State Laws regarding the non-collusion bidding certification. No separate forms will be required, but the actual signing of the proposal includes such a statement and is included in the proposal.

The Town Board expressly reserves the right to waive any informalities in or to accept and award any bid, or to reject any and all bids, or to award on any or all items, as the interest of the Town of Ulster may appear to require.

The Town of Ulster is an exempt organization under the Tax Laws and is exempt from payment of Sales and Compensating Use Taxes of the State of New York and Cities and Counties of the State of all materials which are to be incorporated into the project, pursuant to the provisions of the Contract. These taxes are not to be included in the Bid.

No bidder may withdraw his bid within 60 (sixty) days after the actual date of the opening thereof.
